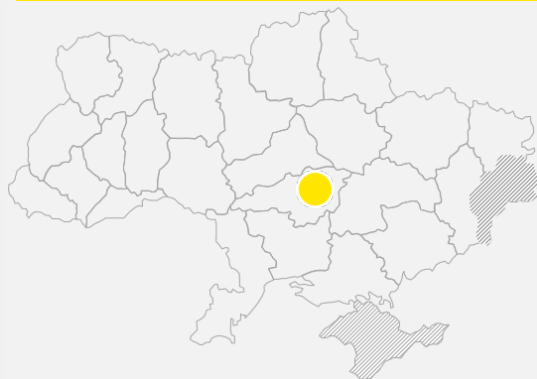

General characteristics

The main activities in accordance with the statute are:

- cultivation of cereals (except rice), legumes and oilseeds;
- production, procurement and processing of industrial cocoons of mulberry silkworm;
- growing mulberry seedlings to restore mulberry plantations;
- carrying out economic activities for the production of agricultural products, their processing, storage and sale;
- other activities.

Agricultural products produced:

- winter wheat;
- winter barley;
- sunflower.

The property complex includes:

- vehicles - 7 units;
- machinery and equipment - 14 units;
- tools, devices, inventory, perennial plantings (black mulberry, apple, cherry), low-value non-current tangible assets and real estate.

The state enterprise has the right to permanent use of agricultural land located on the territory of Andriyivka village council of Oleksandria district of Kirovohrad region, with a total area of 304.8819 hectares, including:

- arable land - 97.3073 hectares;
- pastures - 20.3541 hectares;
- perennial plantings - 187.2205 hectares.

Privatization conditions

- ❑ Succession of all property rights and obligations of the privatized enterprise, except for the right of permanent use of land plots;
- ❑ Preservation of the main activities of the enterprise for 5 years;
- ❑ Prevention of dismissal of employees for 6 months;
- ❑ Fulfillment of the terms of the collective agreement is maintained during its term, but not more than 1 year;
- ❑ Repayment within 6 months of debts on wages, taxes and overdue accounts payable.
