

## **Administrative Non-residential Building**


- 126, Hrushevskoho St., Chaplinka small town, Kherson region

## **Object of Unfinished Building**


- 7, Ukrainska St., Zhurivka small town, Kyiv region




#### **Non-residential Premises**


# **Veterinary Medicine Laboratory**


147, Lesi Ukrainki St., Krolevets town, Sumy region

The facility has not been used since 2017. Land plot is not separately allocated. The privatization object is not leased.












## PJSC "Kherson plant "SUDMASH"
