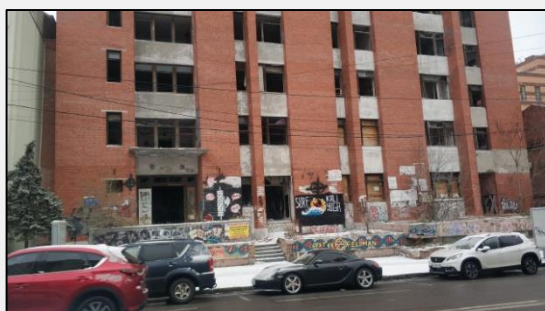

Information on lease agreements concluded for the object: there are no lease agreements.

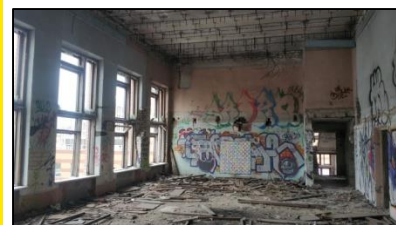
There are no objects on the company's balance sheet that are not subject to privatization.
