## <mark>Mine №10</mark> "Novovolynska"

**General characteristics** 

The construction of Mine №10 "Novovolynska" has been carried out since 1989 at the expense of the state budget. Design capacity: 900,000 tons of coal per year.

At present, the construction is continuing, underground mine workings are being built and the technological transport chain is being installed in underground conditions on 355 and 425 meter horizons. **Level of construction readiness: 87.6%** 

The construction project consists of 34 separate technological complexes located on the industrial site of the mine, namely:

- The main shaft
- Auxiliary shaft
- Underground mines
- A block of buildings and structures of the auxiliary shaft (over mine building, administrative block, household block, lamp room, meeting hall, laundry rooms, dining rooms)
- Lifting of the main shaft (overhead building, lifting device)
- Lifting of the auxiliary shaft (the building of the lifting unit)
- Loading and warehousing (loading hoppers, gallery from the main shaft block to loading hoppers)
- Ventilation (main ventilation unit building)
- Block of auxiliary services
- Block of auxiliary workshops
- Fire department for two cars
- Boiler building

Some of these buildings and structures are equipped with:

- technological and electrical equipment;

- stationary installations for supplying air, electricity and pumping water from underground workings.

- lifting machines, cages for lifting people, goods, oversized materials;

- technological underground and surface transport links;
- water heating and heating installations for heating shafts;
- mining equipment for the construction of underground mines and surface complex.

In accordance with the requirements of Article 20 of the Law of Ukraine "On Privatization of State and Municipal Property" in cases provided by the legislation on protection of economic competition, the buyer must obtain permission from the Antimonopoly Committee of Ukraine to directly or indirectly acquire assets in the form of a property complex or structural business unit (hereinafter - the concentration permit). The procedure for filing and reviewing an application for a concentration permit is established by the legislation on the protection of economic competition.



The object of unfinished construction is located on ten land plots with a total area of 88,432 hectares, according to state acts on the right of permanent use, namely:
