General characteristics

The main activity according to the Charter: activities in the field of engineering, geology and geodesy; provision of technical consulting services in these areas.

The volume of sales of products (works, services) for the period of 2020 - 1st half of 2023: UAH 136,328 thousand, including export - none.

The main product range as of June 30, 2023: engineering services - development of design and estimate documentation and its examination.

Information about the object (real estate): the object includes 33 registered units of real estate and infrastructure (production, storage, administrative buildings and structures) with a total area of 14,967.72 sq. m located at the following addresses:

- Dnipropetrovsk Oblast, Kryvyi Rih town, 40, Pochtoviy avenue;
- Dnipropetrovsk Oblast, Kryvyi Rih Rayon, Kudashivka village, 7, Livoberezhna storona St.

Information about vehicles: 15 units of vehicles and special equipment, incl. 4 vehicles that were transferred to the Ukrainian Armed Forces.

Information about land plots: 2 registered land plots with a total area of **2.7589 hectares**.

According to the information provided by the enterprise and the information contained in the technical documentation on land management for establishing (restoring) the boundaries of a land plot in kind (on the ground), in the permanent use of the SOE "State Institute for Design of Mining Enterprises "Kryvbasproekt" at the address Dnipropetrovsk Oblast, Kryvyi Rih town, 40, Pochtoviy avenue there is a land plot with an area of 1. 4175 hectares, of which cadastral number 1211000000:08:306:0029 was assigned to 1.3378 hectares for the intended purpose - for the construction and maintenance of buildings and structures of scientific institutions (land purpose code: 03.11). The remainder with an area of 0.0797 hectares, out of a total area of 1.4175 hectares, is under the right of joint use with CB Privatbank, included in the area of the local area of 0.2325 hectares, to which cadastral number 1211000000:08:38 for location of the CB Privatbank branch was assigned. Land area on 12a, Girnychozavodska St. is 0.36 hectares. As of August 01, 2023, part of the real estate of the State Enterprise with a total area of 912.75 sq. m. is leased in accordance with **4 contracts**. The maximum validity period of

existing lease agreements is **until February 23, 2027**.

In accordance with the requirements of Article 20 of the Law of Ukraine "On Privatization of State and Municipal Property" in cases provided by the legislation on protection of economic competition, the buyer must obtain permission from the Antimonopoly Committee of Ukraine to directly or indirectly acquire assets in the form of a property complex or structural business unit (hereinafter - the concentration permit). The procedure for filing and reviewing an application for a concentration permit is established by the legislation on the protection of economic competition.
