General characteristics

The main activity according to the Charter: research and experimental developments in the field of other natural and technical sciences.

Products: absent (the enterprise has not been engaged in production since 2011).

Real estate: the object includes 1 object of real estate and infrastructure objects (administrative and laboratory building with a total area of 6,053.4 sq.m., roads, fence). The assets of the state institution also include:

- underground cable lines of 665 running meters;
- heat lines of 180 running meters;
- sewerage of 388 running meters.

Land plots: 1 registered land plot with a total area of 0.1032 ha.

Also, the institution was allocated a plot of land with an area of **4.0 ha** for the construction of a laboratory building, which is not registered, technical documentation has not been developed.

The institution's property is not leased.

In accordance with the lease agreement #1347 dated 19.11.2012, the term of which expired on 18.09.2018, the Executive Committee of Vyshnev City Council of Buchansky district of Kyiv region continues to lease property - non-residential premises with a total area of 1,426.2 sq.m. (non-residential premises of 1,143.4 sq.m. and an assembly hall of 282.8 sq.m).

On the balance sheet of the enterprise there is an object that is not subject to privatization - a protective structure of civil protection - a bomb shelter with a total area of 376.5 sq.m., located in the basement of the administrative and laboratory building, which belongs to the state property and is under the management of the Ministry of Economy of Ukraine.

The enterprise did not receive government orders, mobilization tasks.

In accordance with the requirements of Article 20 of the Law of Ukraine "On Privatization of State and Municipal Property" in cases provided by the legislation on protection of economic competition, the buyer must obtain permission from the Antimonopoly Committee of Ukraine to directly or indirectly acquire assets in the form of a property complex or structural business unit (hereinafter - the concentration permit). The procedure for filing and reviewing an application for a concentration permit is established by the legislation on the protection of economic competition.
