

General charasteristics

The main type of activity according to the Charter: other personal service activities n.e.c. (NACE code 96.09). Volume of products (works, services) for the period 2020 – 9 months of 2023: UAH 131,576.80 thousand, including export – UAH 0.0 thousand.



- preventing the dismissal of employees during 6 months.




