### **General charasteristics**

**Main activity according to the Statute:** extraction of peat (according to the NACE code 08.92).

The volume of sales of products (works, services) for the period 2020 – 9 months of 2023: UAH 28,070.800 thousand, incl. export - UAH 0.0 thousand.

Main product range: sale of peat.

**Description:** the property complex includes the "Olevsktorf" subsidiary, USREOU code 24698867 (Zhytomyr Oblast, Korosten Rayon, Olevsk town, 66, Promyslova St.), which is in a state of termination and a Ozeryansky peat plant branch separate structural subdivision of SE "Zhytomyrtorf" USREOU code: VP:24698873 (Zhytomyr Oblast, Korosten Rayon, Myrolyubiv urban-type settlement, 5, Zavodska St.).

**Information about the object (real estate):** the object includes **70 registered units of real estate and infrastructure** (production, storage, administrative buildings and structures) with a total area of **20,345.6 sq. m** located at the following addresses:

- Zhytomyr Oblast, Zhytomyr, 25, Velika Berdychivska St.;
- Zhytomyr Oblast, Korosten Rayon, Olevsk town, 66, Promyslova St.;
- Zhytomyr Oblast, Korosten Rayon, Olevsk town, 41, Robitnycha St.;

Information about vehicles: 134 units of motor vehicles and special equipment (10 of which were transferred). Information about movable property: machinery and equipment in the amount of 314 units, other fixed assets - 30 units, tools, appliances, inventory - 159 units.

The property complex of SOE "Zhytomyrtorf" also includes the "Gat" reservoir, the "Hvozd" reservoir, a fire ditch.

On the balance sheet of the enterprise there are objects that are not subject to privatization in the amount of 69 units (residential houses, sheds to houses, hostels, antiradiation shelter, etc.).

**Information about land plots: 4 land plots** (including 2 registered land plots) with a total area of **6.4583 ha**. According to the information of the enterprise, the land plot with an area of about 6 hectares under the complex of buildings and structures No. 2 (outside the settlement on the territory of the Olevsk territorial community) has not been separately allocated, there is no cadastral number of the stead.

In accordance with the requirements of Article 20 of the Law of Ukraine "On Privatization of State and Municipal Property" in cases provided by the legislation on protection of economic competition, the buyer must obtain permission from the Antimonopoly Committee of Ukraine to directly or indirectly acquire assets in the form of a property complex or structural business unit (hereinafter - the concentration permit). The procedure for filling and reviewing an application for a concentration permit is established by the legislation on the protection of economic competition.
