# **General characteristics**

Amount of the authorized capital: UAH 798,544,000

**Main activity:** Production of fertilizers and nitrogen compounds, particularly ammonia and urea, as well as overloading for the export of ammonia, urea and methanol of other enterprises and of own production. 85% of products are exported to more than 30 countries.

OPP has excellent primary access to port facilities, which allows the load type "Panamax" (50-60k MT) vessels:

- berth No 1 and No 2: bulk;
- berth No 3: ammonia;
- berth No 4: liquid bulk.

#### **Production facilities:**

- 2 ammonia production units with an annual capacity of 550,000 tons each;

- 2 urea production units with an annual capacity of 430,000 tons each;

- Ammonia transshipment complex with an annual capacity of up to 4 mln tons, with a storage facility of up to 120,000 tons;

- Urea overloading complex with an annual capacity of up to 3.6 million tons, with a storage warehouse for 80,000 tons;

- A methanol transshipment complex with an annual capacity of up to 1 mln tons, with a storage facility for 36,000 tons;

- Department of liquid carbon dioxide production with an annual capacity of up to 16,000 tons.

Transport: 120 units of vehicles and special equipment.

#### Land plots:

- 24 land plots in use with a total area of 252.41 hectares;
- **11 rented land plots** with a total area of **67.86** hectares.
