According to information from the Main Directorate of the State Fiscal Service of Ukraine in the Chernihiv Oblast (letter No. 1895/5/25-01-13-02-09 dated September 12, 2022), the SOE "Chernihiv Regional Production and Technical Center for Standardization, Metrology and Product Quality "Chernihivoblagrostandard" takes into account the tax debt in the amount of UAH 70,649.79. The tax lien was registered on September 24, 2018. According to the Act No. 30 of the State Fiscal Service of Ukraine in the Chernihiv Oblast dated September 21, 2018, 8 units of movable property were described as tax liens.

There are no lease agreements for the leased property as of April 01, 2024.

There are no objects on the company's balance sheet that are not subject to privatization.

There are no protective structures – civil defense facilities – on the company's balance sheet.

There were no emissions or discharges of pollutants into the environment, no waste was generated or disposed of due to the fact that the enterprise has not been operating for several years.
