

### **General characteristics**

**The main activity according to the Charter:** engineering activities and related technical consultancy.

The enterprise has the necessary license, permit and declarations of compliance of material and technical base and working conditions with the requirements of the legislation on labor protection and industrial safety for carrying out business activities.

The volume of sales of products (works, services) for the period of 2021 – Q3 2024: UAH 19,439.0 thousand, including export - none.

There are no environmental taxes charged and paid according to forms No. 2-TP (air) (annual) and No. 1-waste (annual) at the enterprise.

The enterprise pays environmental tax for emissions of gas boiler, which heats the premises in winter time.

According to the tax declaration for 2021-2023 and 9 months of 2024, the environmental fee has been charged and paid in the total amount of UAH 84.76, including: 2021 – UAH 29.11, 2022 – UAH 20.13, 2023 – UAH 20.80, 9 months of 2024 – UAH 14.72.

### **Privatization conditions:**

- repayment of debts on wages and to the budget within 6 months;
- preventing the dismissal of employees during 6 months.
