General charasteristics

The main type of economic activity according to the Charter: distilling, rectifying and blending of spirit (NACE class 11.01).

The company has the following licenses:

- License for the production of alcoholic beverages, registration number 990108202100031 dated 08.04.2021, valid until 10.04.2026;
- License for the right to wholesale alcoholic beverages, except cider and perry (without added alcohol), registration number 990208202100093 dated 16.12.2021, valid until 27.12.2026.

The property complex includes a separate subdivision Chudniv Branch of the SOE "Zhytomyr Distillery Plant" (USREOU code 33177999, address: 7, Sadova St., Chudniv town, Zhytomyr Rayon, Zhytomyr Oblast, 13200).

Volume of sales of products (works, services) for the period of 2022 - 2024: UAH 347,124.0 thousand, including export sales of UAH 523.0 thousand.

The main range of products (works, services): alcoholic beverages, alcohol, alcoholic juices, including export: alcoholic beverages.

Real estate information: the privatization object includes **147 units of real estate** (buildings, structures) with a total area of **24,320.5 sq. m**, engineering networks located at 38, Svyatoslava Richtera St., Zhytomyr city and in the Zhytomyr Oblast.

Information about the land plots: 13 land plots with a total area of **17.9337 ha**.

Vehicle information: 47 units of registered motor vehicles and special equipment manufactured in 1969 – 2018.

As of 01.03.2025, the company's property is not leased. The company's balance sheet includes 3 objects that are not subject to privatization (2 anti-radiation shelters (civil protection facilities), a gas pipeline to 24- and 8-apartment houses).

The procedure for filling and reviewing an application for a concentration permit is established by the legislation on the protection of economic competition.
